**DOCUMENTS REQUIRED TO BE SUBMITTED TO ZSB IN A CLOSED FOLDER**

- Common Documents Required** -Copy of Discharge Book, PPO, ZSB ID Card of ESM/Widow, Aadhaar Cards of all.
- Children(Above 20 Yrs Age) and Parents –Dependency, Unmarried and Income below Rs 9000/-PM Certificate from Municipality/Gram Panchayet.**
- Widow Daughter-** Death Certificate of husband and Dependency cum income certificate from Municipality/Panchayet.
- Divorcee Daughter-**Divorce Decree from Court and Dependency cum income certificate from Municipality/Panchayet.
- Photo-**One recent Colour Photo **2cm X 2.5 Cm in White/Light colour Dress, NOT more than 3 Months old** of each Dependent to be given in a small envelope for pasting on the Dependent ID Card.
- Fees for DIC.** Rs 100/- to be paid in cash for each Dependent ID Card while submitting Application Folder.

**NOTE-1:** ALL APPLICANTS ARE REQUESTED TO READ THE INSTRUCTIONS AND USE **NEW OFFLINE FORM** GIVEN IN THE ZSB TELEGRAM GROUP ON 30/11/2023, REGARDING DEPENDENT ID CARD, BEFORE APPLYING FOR DIC.
